### **RECOMMENDATIONS:**

Staff recommends that the Board approve an amendment to the contract with Hartzell General Engineering Contractor, Inc. (Hartzell), authorize the General Manager to execute the amendment, subject to the review and approval of District Counsel, in an amount not to exceed \$30,618.88, and adopt Resolution 38-2021 amending the Fiscal Year (FY) 2021/2022 Budget.

### FISCAL IMPACT:

The FY 2021/2022 adopted Water Fund – Water Operations budget includes \$195,374, for the Zone 2 to Zone 7 Santa Rosa Bridge Waterline Project (Project), of which \$170,000 is committed for the contract with Hartzell. The remaining budget of \$25,374 is insufficient to cover the cost of the amendment. A budget adjustment is requested in the amount of \$5,245 and will be funded from Water Fund reserves, as provided in the chart below. The Water Fund reserves are estimated to be \$395,407 at June 30, 2022.

## **DISCUSSION:**

On May 20, 2021, the Board authorized staff to proceed with a Request for Proposals for the Project. Hartzell was the responsive low bidder and was awarded the contract, which was executed on June 25, 2021. The original contract was for \$170,000, but, due to field conditions unforeseen in the design drawings, a change order for an additional \$30,618.88 has been requested, which requires amending the contract.

The Project will replace a broken high-pressure water pipeline which was temporarily bypassed in 2017. The abandoned pipeline, which runs underground behind the Bluebird Inn property, will be left in place and the temporary pipeline, located on the pedestrian bridge crossing Santa Rosa Creek, will be removed. The replacement pipeline will be approximately 160 linear feet long and will be hung on the outside of the bridge hand railing on the downstream side.

This Project is a Priority 1 item on the District's Capital Improvement Plan for the Water Department. Due to permitting constraints, Project implementation has been delayed for several years. The District has obtained approval to proceed with the Project from the California Department of Fish and Wildlife (CDFW) through their Lake or Streambed Alteration Notification Program. Part of this Project approval includes completing all work in the creek during the dry season.

Due to the nationwide shortage on pipe materials and rapidly approaching deadlines contained with the CCSD's permit approval, the District Engineer directed the expediency of this change order. All line items were reviewed and verified by MKN Engineers (Pipeline) and by SSG Engineers (Structural) to ensure consistency with the original specifications and/or evaluate the necessity for deviation from the specifications. Attachment 1 describes the change order request in detail, but it is summarized as follows:

- Labor and materials for additional buried pipe required due to discrepancies between the record drawings and field conditions.
- Labor and materials for additional above-grade coated pipe and structural hangers to realign pipe north of the bridge from buried, to suspended from the bridge abutment.
  - This revision was made to avoid earthwork required to bury the pipe.
  - This additional earthwork would have impacted property beyond the District's easement and may have triggered additional permitting requirements.
- Labor and material for various pipe fittings to accommodate the revised alignment north of the bridge.
- The District was credited for the buried pipe that was eliminated from the design.

Staff recommends the Board approve the requested amendment to the contract, authorize the General Manager to execute the amendment, subject to the review and approval of District Counsel, and adopt Resolution 38-2021 amending the FY 2021/2022 Budget.
